Ingredients: Glucosamine sulfate (D-glucosamine sulfate potassium chloride) (from crustaceans); hydrolyzed fish collagen; glazing agent: gelatin; chondroitin sulfate (chondroitin sulfate sodium salt) (from fish); sodium hyaluronate (hyaluronic acid); ginkgo biloba extract (Ginkgo biloba L.) DER 4; 1; methylsulfonylmethane; boswellia serrata extract (Boswellia serrata Roxb. ex Colebr) DER 4; 1; color: titanium dioxide; anti-caking agent: magnesium salts of fatty acids.

NutraFlex is a combination of **Glucosamine, Hydrolyzed fish collagen, Chondroitin, Hyaluronic Acid, Ginkgo Biloba Extract, MSM and Boswellia Serrata.**

Glucosamine Sulfate, Chondroitin Sulfate and Hyaluronic Acid are natural substances found in the tissue of the joints.

NutraFlex reduces the symptoms of Osteoarthritis- the most widespread type of the degenerative joint disease: joint pain, stiffness, reduced flexibility and gradual deformation of the affected joint. **Glucosamine** is a natural element formed in our bodies from glucose. With age, the amount of Glucosamine that our bodies create decreases. As a result, cartilage and bones begin to get damaged, as well as joints because lubricants and synovial fluid decrease. Glucosamine helps the formation and repair of cartilage.

Chondroitin (a carbohydrate) is a component of the cartilage, which prevents water penetration into tendons and joints. It prevents joints destruction and helps the mechanical characteristics of the joints.

Fish collagen is a complex structural protein that helps maintain the strength, flexibility of joints and also supports bone health. It has ability to increase the body's own natural collagen production. Collagen makes up 90% of the organic matrix of our bones -One of the most common signs of aging is the loss of bone mass-

Hyaluronic Acid is found in the highest concentrations in fluids in the joints. It works by acting as a cushion and lubricant in the joints, keeping the space between your bones well lubricated and reducing joint pain.

MSM (Methyl Sulfonyl Methane) is a source of organic sulphur, which takes part in collagen formation and cartilage preservation. MSM is effective in reducing joint pain, stiffness and swelling. Arthritis as a form of gradual degeneration of the joints is an inevitable result of the aging process.

Boswellia Serrata is a plant which resin has anti-inflammatory properties and its derivatives have anti-cancer properties. Extracts of the dried resin from the Boswellia Serrata tree have been used since ancient times in India to treat inflammatory conditions. The standardized Boswellia Serrata extract is used to help the functioning of the joints and their mobility.

Ginkgo Biloba acts as an anti-inflammatory and pain-relieving agent. It also boosts up the immune system, reduces chondrocyte destruction and helps maintain the proper brain performance in elderly people.

NutraFlex contains revolutionary ingredients Glucosamine Sulfate, Hydrolyzed Fish Collagen, Chondroitin Sulfate, MSM, Hyaluronic Acid, Boswellia Serrata Extract and Ginkgo Biloba Extract and allows you to experience a great benefit to your health by consuming NutraFlex as a nutritional supplement.

NutraFlex is recommended for: In case of premature (early) wearing out of the joints; Promoting recovery process after traumas; In case of joint tension and pain.

Warning:

Glucosamine may increase insulin resistance. Those with type 2 diabetes and those who are overweight and have problems with glucose tolerance should have their blood sugars carefully monitored if they use glucosamine supplements. Because of insufficient safety data children, pregnant women and nursing mothers should avoid using glucosamine.

Do not exceed the recommended daily dose. Do not use the product as a substitute (replacement) for a varied diet. Do not ingest if you are allergic to any of the ingredients. The product contains fish and crustaceans derivatives.

Recommended daily Dose:

1 capsule daily, as a dietary supplement, preferably with meals.

Administration:

The capsules should be taken orally with a small amount of liquid.

Recommended usage period:

From 3 to 6 months. This period can be extended up on a physician prescription.

Storage conditions:

The dietary supplement should be stored in dry place at 8-25 ° C in closed container. Dietary supplements should be kept away from children and sunlight exposure.

Packaging:

15 capsules in blister
4 blisters with packaging leaflet in a carton box.
