### PRODUCT INFORMATION

Each 5 ml (1 teaspoonful) contains:

Vitamin B3 (Nicotinamide)	10mg
Vitamin B1 (Thiamine mononitrate)	10mg

Lysine HCL	50mg
Cyproheptadine	1.9mg

### INGREDIENTS:

Purified water, Lysine HCL, Nicotinamide, Thiamine mononitrate, Riboflavin, Pyridoxin hydrochloride, Cyanocobalamin, Cyproheptadine, Xylitol, Sweet cherry, Cherry aroma, Citric acid, Xanthan gum, Potassium sorbate.

NutraDine Syrup is a combination of Cyproheptadine, Lysine and B Vitamins. That helps to promote appetite, boost the immune system, support energy metabolism and stimulate the release of human growth hormone.

Cyproheptadine is a potent competitive antagonist of both serotonin and histamine receptors, antagonism of serotonin on the appetite center of the hypothalamus may account for cyproheptadine's ability to stimulate the appetite.

Lysine is an essential amino acid that may help to stimulate growth hormone (GH) release, helps in the synthesis of collagen tissue and improve immunity; it may facilitate the absorption of calcium from the small intestine. Lysine is also an appetite-stimulant.

B Vitamins support energy production by aiding in the metabolizing of fats, carbohydrates, and proteins. Help to absorb the amino acid lysine through the intestine. B vitamins are also needed for nerve cells and red blood cells, and to make DNA.

### INDICATIONS:

- Stimulates the appetite and may lead to weight gain, which is helpful for underweight people.
- In case of Poor appetite.
- Stimulates the release of human growth hormone suggesting a potential role in increasing child height.
- Essential for proper growth & development.
- Helps boost the immune system.
- Improves sleep, calmness, as well as mood and energy levels.
- Important for collagen synthesis and maintaining good bone health.
- Supports the development of genetic material, the production of red blood cells, nervous system function.

### DIRECTIONS:

Age	Dosage
2-8 years	5ml, once daily
